

## **CAR SHARING ROMA "INVITE A FRIEND" PROMOTION REGULATIONS**

### **TYOLOGY AND DENOMINATION**

Promotion called INVITE A FRIEND (hereinafter referred to as "PROMOTION").

### **PROMOTER SUBJECT**

The Promotion is organized by Roma Servizi per la Mobilità S.R.L., with registered office in Via Vigna Murata 60, 00143, Rome, Tax Code and VAT number 10735431008 (hereinafter referred to as "PROMOTER").

### **RECIPIENTS**

The PROMOTION is aimed at all customers of the Car Sharing Roma, holders of a contract of category "Individual" or "Family" category contract holders (hereinafter "INVITING CLIENT"), who have invited a new person (hereinafter "INVITED CLIENT") to subscribe to the above mentioned Car Sharing Roma service and to take advantage of the PROMOTION herein described. This PROMOTION will be activated after the completion of the registration of the "INVITED CLIENT" to the Car Sharing Roma service with a contract in his/her name of the category "Individual" or "Family".

### **GENERAL RULES**

The PROMOTION is an initiative aimed to the INVITING CLIENT and the INVITED CLIENT who receive a credit of 20€ each, which can be used on subsequent rentals of Car Sharing Roma vehicles until the amount is exhausted.
